Financial Arrangements for _____ (Print child's name)

The Red Apple School, Inc. is a licensed and nationally accredited child day school. It is not a child daycare center. We employ yearly contracted professional early childhood teachers and we maintain small classes. Tuition is based on the cost of operating the school for the Commonwealth of Virginia's prescribed 180 day school year (typically starting in mid-August through May.) For your convenience, tuition is divided into ten (10) equal payments. This contract is for the entire school year. When you sign this contract, you are agreeing to pay for the full year, unless you meet the Early Withdrawal Requirements listed below. Normal payment schedule for the ten (10) payments is a payment the 15th of each month from July 15 through April 15. Students who enroll after July 15 will pay the registration and supply fees and may have an adjusted payment schedule through May 15. All payments must be completed by May 15.

Early Withdrawal Arrangements

Students who withdraw between July 1 through the first full week of the school year may do so with no additional costs except the first month tuition. The first month payment is not refundable. Beginning with the second full week of school, the parents are obligated for tuition for the entire fall semester ending in December.

Students may withdraw from the second semester (January-May) with written notice (either letter or email) submitted and received by the Red Apple School, Inc. by November 15. If written notification is not received by November 15, parents/ guardians are obligated for the remainder of the school year unless we are able to fill the vacated space.

Kindergarten is a full year program and is not eligible for early withdrawal.

Military families may terminate this agreement upon giving 30 days written notice to the Red Apple School, Inc with a copy of their official transfer orders. The official transfer date from the local area will be the basis for the termination of this agreement. The final monthly payment will be paid in full based on the official transfer date and will not be pro-rated.

Tuition is due the fifteenth of the month. After the **first** of the month, a late charge of **\$35** will be assessed.

All tuition must be paid each month before your child will be allowed to attend the next month.

Tuition for the second child in the same family will be 10% less for the lesser tuition only (rounded up to the next whole dollar).

A **\$37** service charge will be assessed on all returned checks.

Medical

The Red Apple will retain an Emergency Medical Authorization and Consent form (Required by Licensing) authorizing the Red Apple to seek medical attention for your child in the event of an emergency when you cannot be reached. You will be responsible for payment of any resulting expenses.

Virginia requires you to report to the school serious contagious disease. See the parent handbook for details.

I/We agree to pay all costs and expenses including, without limitation, court costs and reasonable attorney and collection agencies fees incurred by The Red Apple School, Inc. in connection with the collection of tuition and the enforcement of this agreement. Interest charges for payments overdue by more than 30 days will be calculated at 1.5% per month.

I/ We have read the above contract and agree to the terms as stated. I/We also understand that no exceptions to this agreement will be allowed without express written permission from the Red Apple School, Inc. management.
